

Adams Diversified Equity Fund, Inc. (NYSE: ADX) 2024 Quarterly Distribution Payable on December 23, 2024

Notification of Sources of Distributions Pursuant to Section 19(a) of the Investment Company Act of 1940

The distribution of \$1.96 per share, optionally payable in additional shares of Common Stock or in cash by specific stockholder election, is to be paid on December 23, 2024, to stockholders of record at the close of business on November 22, 2024 (ex-dividend also on November 22, 2024). The reinvestment price is \$20.73, the Fund's closing NYSE market price on December 11, 2024, the valuation date.
