



Adams Natural Resources Fund, Inc. (NYSE: PEO) 2026 Quarterly Distribution Payable on May 27, 2026

Notification of Estimated Sources of Distributions Pursuant to Section 19(a) of the Investment Company Act of 1940

The distribution of \$0.52 per share, optionally payable in additional shares of Common Stock or in cash by specific stockholder election, is to be paid on May 27, 2026, to stockholders of record at the close of business on April 27, 2026 (ex-dividend on April 27, 2026). The reinvestment price is \$26.45, the Fund's closing NYSE market price on May 15, 2026, the valuation date.

² The Annualized Current Distribution Rate is the current quarter's distribution rate per share annualized and expressed as a percentage of the Fund's NAV per share as of March 31, 2026.

³ The Cumulative Fiscal Year Distribution Rate is the distributions per share for the current fiscal year period, expressed as a percentage of the Fund's NAV per share as of March 31, 2026.
